Economy to bounce back once vaccination gathers momentum

According to Malaysian Academy of Sciences fellow Datuk Dr Madeline Berma, economists predicted that Malaysia would be able to revive its economy starting in the third quarter of this year, depending on the smooth implementation of the vaccination programme. This is in line with the forecast issued by the Economic Planning Unit (EPU) which expects the country's economy to recover around 4.5 to 5.0%. The services sector was one of the sectors that needed to be given priority in the vaccination programme, besides the manufacturing sector to help increase production rates. It is hoped that with the national immunisation programme underway, the country's tourism and export sectors could also be mobilised again to open more economic opportunities for industry players. The country's tourism and export sectors have been badly affected by the closure of national borders since the Movement Control Order was imposed. Meanwhile investments from international pharmaceutical companies in the research and production of the Covid-19 vaccine in the country could help reduce the unemployment rate and open up opportunities for recruitment of highly skilled graduates. The presence of pharmaceutical companies that could create jobs will drive the country's economy and instil confidence in foreign and local investors that the country's economy is growing and recovering well with a good cycle. This is a good development in the effort towards a high-tech blueprint in line with the launch of the Malaysia Digital Economy Blueprint.

IATA plans digital travel pass to steer airlines towards recovery

According to International Air Transport Association (IATA) director general Alexandre de Juniac, the outlook for airlines has been weakened recently by tightening coronavirus restrictions but said it was preparing for a travel recovery later this year and would launch a digital travel pass in March. The sector would continue to bleed cash this year and raised its forecast for total annual airline cash burn to between US\$75 billion and US\$95 billion (RM303 billion and RM383.8 billion), up from the US\$48 billion it had forecast in December but still well short of roughly US\$150 billion last year. Despite mounting losses the industry focus is on how travel can restart at scale when borders are finally reopened and huge pent-up demand is released. IATA needs to plan for the recovery and a way to digitally manage health credentials and secure a global standard to record test results and vaccinations. IATA's travel pass, which will be formally launched at the end of March, will help to facilitate travel by putting Covid-19 test results and vaccine certificates in one digital format, speeding up check-in processes. This summer is make or break for many airlines struggling to survive after a year of minimal revenue owing to the pandemic. As restrictions ease, digital systems will be needed to accommodate rising passenger numbers. Britain's Heathrow Airport takes 20 minutes per passenger to check paper test results and passenger locator forms, something

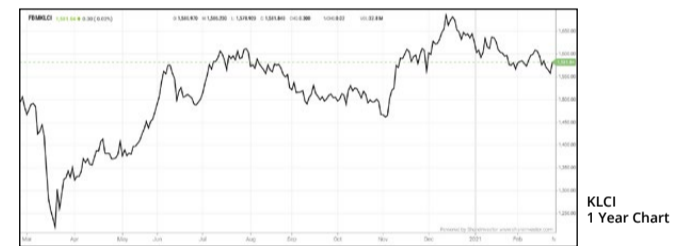
that is only possible when passenger numbers are so low. Vaccinations give hope that more travel will be allowed but countries need to issue digital proof to allow travel to take off. Despite vaccine rollouts, the emergence of more infectious variants in countries such as Britain, Brazil and South Africa has forced governments to bring in new travel restrictions this year. But there is light at the end of the tunnel. Britain was praised for setting out its plans to restart travel. Holiday bookings flooded in after the UK said international travel could resume from mid-May, depending on progress against the virus.

Stockbrokers welcome extension of temporary suspension on IDSS and PDT Short Sale

The Association of Stockbroking Companies Malaysia (ASCM) has welcomed the extension of the temporary suspension of Intraday Short Selling (IDSS) and the Intraday Short Selling by Proprietary Day Traders (PDT Short Sale) to Aug 29, 2021. The extension of the temporary suspension for another six months will indeed help further stabilise and strengthen the present market conditions and increase the confidence of the market participants. The Secretariat Office of ASCM commended the Securities Commission Malaysia and Bursa Malaysia for their response to the challenges of the Covid-19 by taking various measures, including regulatory relief consideration, for the securities industry with remarkable commitments and dynamism in assisting the industry to navigate through this pandemic. On the securities industry side, ASCM is also taking necessary contingency measures and plans to manage potential disruptions caused by the pandemic and to ensure the smooth running of the industry and preserving the integrity of the market.

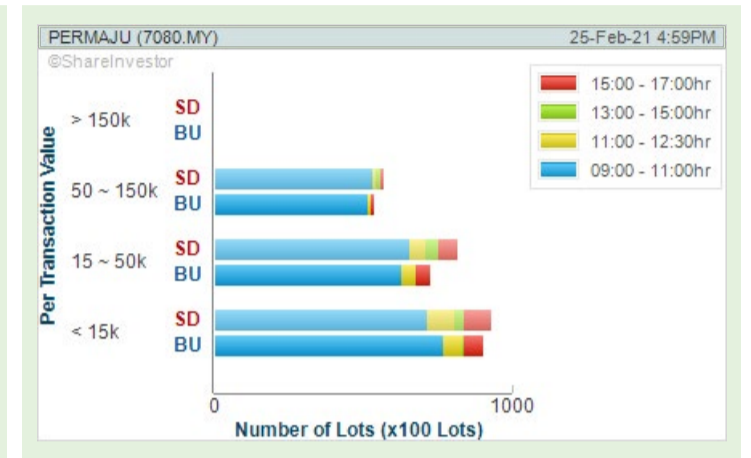

Advance Synergy Berhad

The Board of Directors of Advance Synergy Berhad (**ASB**) wishes to announce The Group recorded gross profit margin on its system sale contract revenues of 59.4% in 2020, higher against the 53.9% margin recorded in 2019. This is attributable to the lower proportionate contribution of system sale contract revenues from GlobeOSS, which generally delivers lower gross profit margin. The Group recorded consolidated revenue of S\$21.361 million for the financial year ended 31 December 2020 ("2020"), a decrease of 10.3% against the revenue achieved in the corresponding financial year ended 31 December 2019 ("2019"). The decline in Group revenue for 2020 is mainly attributable to lower revenue recorded by both GlobeOSS and Unifiedcomms. Unifiedcomms recorded revenue of S\$12.069 million in 2020, a decrease of 6.7% from the S\$12.937 million recorded in 2019. This decline was due to lower system sale contract revenues. The Group's sales mix in 2020 showed an increase in the proportionate contribution of revenue of a recurring



nature, with revenue from managed service contracts representing 73.9% of the Group's total revenue in 2020 as compared to 60.8% in 2019. The shift in the Group's sales mix in 2020 is mainly attributable to a 40.4% drop in system sales contract revenue contribution from Unifiedcomms and GlobeOSS, which declined from S\$9.345 million in 2019 to S\$5.566 million. GlobeOSS recorded revenue of S\$9.292 million in 2020, a decrease of 14.6% from the S\$10.876 million recorded in 2019. This decline was due to lower system sale contract revenues.

The Group reported a consolidated loss before interest, depreciation, and tax of RM0.657 million in the quarter under review compared to consolidated profit before interest, depreciation and tax of RM4.89 million in the preceding year same quarter. The weak performance was mainly due to a) Lower revenue achieved due to the impact of COVID-19, MCO and CMCO. b) The Group received termination fee from the termination of one of the Hotel Management Agreement in Melaka due to the disposal of the hotel in previous year 3rd quarter. There was no termination fee in the current quarter under review.

The Board of Directors of Awanbiru Technology Berhad (**AWANTEC**) wishes to announce The Group's revenue for the current quarter is RM38.1 million, which was RM6.8 million higher than the corresponding quarter of the preceding year of RM31.3 million. This is driven by higher revenue for Software & Services and Talent segment. The current quarter revenue also excluded revenue from Education segment as the results of Prestariang Education Sdn Bhd up to its effective disposal date of 16 November 2020 is classified as results from discontinued operations. The Group recorded profit before tax of RM11.3 million or 424% higher than preceding year loss of RM3.5 million mainly due to gain on completion of the disposal of PESB.

Axiata Group Berhad (**AXIATA**) delivered an encouraging close for the financial year ended 31 December 2020, posting better than expected recovery in the second half of the year post full brunt of the COVID-19 impact. On a reported basis, FY20 revenue dipped marginally to RM24.2 billion year-on-year mainly affected by pandemic-related lockdowns posing distribution challenges and affordability in operating markets. In a positive affirmation of the Group's resilience amidst tough externalities, Earnings Before Interest, Tax, Depreciation & Amortisation rose 0.4% on the back of better performance from most operating companies. As part of improving network resilience and efficiency, a Group-wide 3G shutdown initiative was carried out in FY20 to support the deployment of the more efficient 4G technology and capture increased digital and data demands from customers across the Axiata footprint. This accelerated depreciation of 3G assets coupled with lower one-off gains from the disposal of M1 and Idea rights as well as divestment of non-core digital businesses in FY19 affected Profit After Tax and Minority Interest, which dropped to RM365.2 million in FY20.

Bonia Corporation Berhad

Bonia Corporation Berhad (**BONIA**) registered a revenue of RM83.0 million for the current quarter as compared to a revenue of RM128.2 million recorded in the previous year's corresponding quarter. The revenue decreased by RM45.2 million or about 35.2% was primarily due to subdued consumer spending as a result of the increasing number of the COVID 19 confirmed cases in domestic and overseas markets. The investment and property development segment recorded a minor increase in revenue mainly due to higher rental income received for the current quarter under review. The Group's profit before tax of RM9.0 million reported in the current quarter as compared to the PBT of RM13.2 million reported in the previous year's corresponding quarter, the PBT decreased by RM4.2 million or 31.8% was mainly due to the lower revenue achieved for the current quarter.

The Board of Directors of Sarawak Consolidated Industries Berhad (**SCIB**) is pleased to announce the third interim single tier dividend of 1.9 sen per ordinary share in respect of the financial year ending 31 December 2020. SCIB also recorded revenue of RM185.6 million in the fourth quarter of 2020, as compared to RM28.9 million in the corresponding quarter of 2019, representing an increase of 542% or RM156.7 million. The significant increase of revenue recognized for current quarter was principally derived from the EPCC segment. The Group registered a profit before tax of RM33.7 million as compared to a PBT of RM962,000 posted in the corresponding quarter last year. The improvement in the PBT was mainly due to the higher revenue sourced from EPCC segment in middle east region such as Oman and Qatar. Besides that, during the quarter under review, the Group has recognized a fair value gain on profit guarantee receivable of RM17.7 million. For the year to date, the Group reported revenue of RM516 million in the twelve months period of year 2020, as compared to revenue of RM86 million for the same period last year, representing an increase of 500%. The construction and EPCC segment being the biggest revenue contributor to the Group recorded a total of RM449.9 million. However, the manufacturing division recorded a lower revenue of RM66.2 million for the twelve months period ended 31 December 2020 as compared to the same period in preceding year of RM77.7 million. The lower revenue in manufacturing division reported this year was due to the impact of Covid-19 Movement Control Order which slowed down the economic activity. This in turn has reduced the market demand for manufacturing products during the period under review. The Group achieved a PBT of RM59.5 million as compared to PBT of RM3.2 million recorded in the corresponding period last year. The significant growth in PBT for the twelve months period ended 31 December 2020 was primarily due to the higher revenue contributed by EPCC segment and recognition of fair value gain on profit guarantee receivable. However, there was no contribution from the Property division in the twelve months period of year 2020. The net assets of the Group as at 31 December 2020 stood at RM151.6 million which translates to RM0.31 net assets value per share.
