

# **INVESTMENT THESIS**

Tredegar is a company undergoing a business transition. 11 years ago, it was predominantly a plastic business with an aluminum extrusion business. Today, it is an aluminum extrusion company with a plastic arm. But its performance since then is nothing to shout about. There was hardly any topline growth and profits were volatile leading to a negative average ROE over the past 11 years. This is a cyclical company and my estimate of its intrinsic value based on its normalized performance over the cycle did not provide any margin of safety.

# BACKGROUND


Tredegar is an industrial manufacturer with three primary businesses - aluminum extrusions, polyethylene (PE) plastic films, and polyester or flexible packaging (FP) films. In 2023, the US accounted for about 79% of the company's revenue. Before 2012, plastic products (PE and FP films) were the largest revenue and earnings contributor. However, in 2012, the company made a significant aluminum acquisition that changed its business trajectory.

You can see that today the aluminum business is the largest revenue contributor. Refer to Chart 1.

- In 2023, the aluminum segment accounted for 70 % of the company revenue compared to 33 % in 2013.
- The jump in the contribution from the aluminum segment in 2017/18 was because of another acquisition.


Over the past 11 years, the contribution from the plastic products businesses has been declining. Given the above, I would expect the aluminum business to grow. The key takeaway is that today, Tredegar should be viewed as an aluminum



company with some plastic business.

# **CYCLICAL SECTOR**


The aluminum sector is cyclical as illustrated in Chart 2, making Tredegar a cyclical company.



But while cyclical, prices also have a long-term uptrend. From 1975 to 2022, prices grew at 4.5% CAGR. But in the past 2 years, prices have been extraordinarily high. The implications for my analysis are that we should look at the performance and valuation through a cyclical lens. Using the 2013 to 2023 data would cover at least 2 price cycles. We must also treat the past few years' price data as an outlier.

# **PLASTICS**

Tredegar also faces price cycles for its PE and FP films. The primary raw materials PE films use are polyethylene and polypropylene resins. The FP business produces polyester resins from purified terephthalic acid




and mono-ethylene glycol. As can be seen from Chart 3, the plastic raw materials also appear to be cyclical with outlier prices over the past 2 years.

# **OPERATING TRENDS**

This is not a fundamentally sound company. The revenue in 2023 was lower than that in 2013. Refer to Chart 4. There was hardly any revenue growth over the past 11 years. PAT was very volatile over the past 11 years with 3 years of losses. This led to an average ROE of negative 4%.

- The loss in 2015 was due to impairment of goodwill of USD45 million.
- The loss in 2020 was not only because of COVID-19 but also due to an impairment of USD11 million for goodwill. There was also a USD48 million fair value loss from its 20% investments in a specialty pharmaceutical company.

 The loss in 2023 was mainly due to a 25% decline in revenue and a USD92 million pension settlement. According to the company, this revenue drop was due to excess global capacity.



While gross profitability improved from 2013 to 2020, it has declined

Note: I have converted the various metrics into indices to plot the various metrics on one chart. The respective index was created by dividing the annual values by the respective 2013 values.

since then, so that the gross profitability in 2023 was lower than in 2013.

# GROWTH

The challenge in estimating Tredegar's revenue growth is that the "outlier" prices have skewed its performance over the past few years. There is also a long-term decline in the PE film segment revenue. To get a more representative picture, I think it is more appropriate to look at the weighted average growth from 2013 to 2020. In this context, I estimate its potential growth at 2% as shown in Table 1. This is not a growth company.

# FINANCIAL STRENGTHS

I would rate Tredegar's financial position as average based on the following:

It has a 51% debt-capital ratio as of the end of Dec 2023 which seems on the high side. According to Damodaran Jan 2024 datasets:

- The packaging and container sector average ratio was 38%.
- It was 15% for the building materials sector.
- It was 14% for the metals and mining sector.

Note that Damodaran did not provide any data for the aluminum sector.

From a cash perspective, as of the end of Dec 2023, it had USD10 million in cash and short-term investments. This was only about 2% of its total assets. But it had some positive points. Over the past 11 years

- Except for 2022, it generated positive cash flow from operations every year.
- It generated a total of about USD701 million in cash flow from operations compared to the total PAT of USD61 million. This is a good cash conversion ratio.

It had also a reasonable capital allocation plan as shown in Table 2. The cash flow from operations was about sufficient to fund the dividends & buybacks as well as CAPEX.

# VALUATION

The value of a company depends on its expected future cash flow. In the case of Tredegar, this is dependent on a "normalized" performance. In deriving the normalized performance:

- I considered the 2023 results as an "anomaly" and excluded it;
- I used a weighted average performance of the non-outlier (2013 to 2020) and outlier (2021 to 2022) performances as the normalized performance; and
- I assume a 95% probability for the non-outlier performance and a 5% probability for the outlier performance. I guesstimated the probabilities by looking at the past 40 years' price trends.

On such a basis I estimated the intrinsic value of Tredegar to be USD3.45 per share. The market price of Tredegar was USD5.45 per share as of 31 May 2024. As such there is no margin of safety. (Refer to the original article for details of the valuation model)

# **RISKS AND LIMITATIONS**

By looking at the performvance over the past 11 years, I have indirectly accounted for many of the business and macro risks that the company faced. While I do not have a crystal ball, I am confident that by using "normalized values", I have accounted for much of the ups and downs that are associated with business and macro risks.

Nevertheless, you should consider the following when looking at my valuation:

- I have assumed a 2% growth rate in my valuation. The valuation is very sensitive to the growth rate. If the growth rate was 3%, there would be a 6% margin of safety.
- By excluding the 2023 performance, I have taken an optimistic view in my valuation. But despite this optimism, there is no margin of safety.

# CONCLUSION

Tredegar is a company in transition. It had transformed itself from mainly a plastic products company 11 years ago to mainly an aluminum company today. But I would not consider Tredegar as fundamentally sound based on the following:

- There was no topline growth over the past 11 years. During this period its PAT was volatile with 3 years of losses.
- It achieved a negative average ROE over the past 11 years.
- I rated its financial position as average.

Tredegar is a cyclical company and a valuation over the cycle shows that there is no margin of safety at the current market price.

I am a long-term value investor who has held onto stocks for more than 5 years. My analysis and valuation are from such a perspective. I consider quarterly results "noisy" and focus on long-term trends. 


# So much light outside and you have to turn on the lights inside, this is unnecessary electricity charges and a waste on the grid.

"This room is a good example, when you switch off the lights you won't feel it's very dark because we have put in a skylight," he explained, during Inve\$t's chat session at SkyWorld's office in Ampang. "Similarly, in the apartment, we have to ensure the sunlight can cover up to the kitchen so you don't have to switch on the light even during the daytime. That is a pain of wastage," he added.



## FINANCIAL PRUDENCE POST-IPO, A CORNERSTONE OF SUCCESS

In June last year SkyWorld debuted on Bursa Malaysia, after an oversubscribed IPO priced at 80sen per share, stirring some excitement in the market. A year later, it is charting an ambitious course for the future, focused on strategic land acquisition and customer-centric development, poised for significant growth while staying true to its core values. According to Lee, SkyWorld has only utilised approximately 10% of its IPO proceeds, citing conservative strategies and prudence in scouting land acquisition deals. According to SkyWorld's IPO prospectus, RM100 million has been earmarked for strategic land acquisitions.

However, Lee stressed that the developer's entry into Vietnam to introduce its urban property development business model, will only be when it is assured of at least 10 years' worth of projects to remain sustainable. "We don't just buy a pocket of land here and there—that won't make a real impact for our investors. When we make a move, we do it with a powerful punch! Investors will see that and have unwavering confidence in us," Lee exclaimed, eyes twinkling as he dramatically punched his palm for added emphasis.



# ESG RATINGS FOR MAIN MARKET COMPANIES BY END 2024, ACE MARKET BY JUNE 2025 - BURSA

A ccording to Bursa Malaysia Bhd (Bursa) chairman Tan Sri Abdul Wahid Omar, all Main Market companies will be rated for environmental, social and governance (ESG) by the end of this year, with ACE Market companies scheduled for assessment by June 2025. Currently, about 1,000 companies are listed, with 19 joining up to May this year. The exchange aims to onboard a total of 42 companies this year.

Speaking during a "Ringgit, Bonds, and Equity Markets" panel session at the recent Bank Negara Malaysia Sasana Symposium 2024, he said the idea is to ensure that companies listed on Bursa Malaysia are worthy of investment. Bursa aims for every company to fully embrace sustainability. He added that the exchange began its ESG journey in 2014, collaborating with FTSE Russell to develop the FTSE4Good Bursa Malaysia Index with 24 counters. Now Bursa has 107 counters that make up the FTSE4Good Bursa Malaysia Index, but in his view, it seems small. Hence Bursa is adopting a blanket approach where every single listed company will be rated for sustainability using the FTSE Russell methodology, irrespective of their liquidity. Thereafter, their rating will be published so that every single investor will now have the ability to check the ESG rating of all listed companies.

In addition to ESG, Bursa's commitment to encouraging listed companies to enhance their performance through initiatives such as the Bursa PLC Transformation Programme.



## MALAYSIA'S HEALTH EXPENDITURE TO GROW AT CAGR OF 8.3% FROM 2023 TO 2028 - BMI

ccording to BMI, a Fitch Solutions company, Malaysia's health expenditure is forecasted to grow at a CAGR of 8.3% from 2023 to 2028, with the public portion growing by 8.5% and the private portion by 8.1%. This positive outlook was supported by double-digit increases in the government's healthcare budget in 2023 and 2024 alongside continued advancements in the private sector. This will make Malaysia's medium-term health expenditure growth to be among the fastest in ASEAN.

The ageing population, growing burden of chronic diseases, efforts to enhance public health infrastructure and improved access for underserved communities will drive public sector growth. Private healthcare providers will continue to attract patients with higher incomes including medical tourists and domestic patients looking to avoid long waiting times amid Malaysia's shortage of physicians and nurses. BMI also noted that Malaysia's high single-digit expenditure growth will see it outpace regional peers such as Singapore, Thailand, Philippines and Indonesia over the medium term. Annual per capita health expenditure remains above global and emerging market averages, indicating a strong capacity for spending on advanced medical products. Malaysia will continue developing its healthcare offering to attract medical tourists but will face strong regional competition from Thailand and Singapore. Partnerships are expected to remain a feature of Malaysia's efforts to enhance its medical tourism industry as it seeks to remain competitive amid strong regional competition.



Malaysia will continue to address accessibility challenges in rural areas with the government's 2024 budget highlighting investments in health facilities, including expanding hospitals and building new health clinics to increase capacity and reduce overcrowding. The government is also aiming for a nationwide rollout of electronic medical records by 2026 in a bid to improve the efficiency of the healthcare system.

## AJIYA'S RM250 MILLION LOANS TO CHIN HIN – A STRATEGIC INVESTMENT OR RISKY BET?

n the realm of financial intrigue, the unfolding saga involving Ajiya Berhad (Ajiya) and Chin Hin Group Berhad (CHGB) presents a fascinating case where liquidity, expansion, and potential conflicts of interest intertwine. Ajiya's recently announced RM250 million loan to CHGB is dubbed as a strategic investment,

carrying a 7.5% interest rate per annum. This rate is higher than some of CHGB's current borrowing costs, which range from 3.48% to 8.07%. This raises questions about the attractiveness of the returns to Ajiya, given CHGB's risk profile. CHGB's balance sheet is precarious: a gearing ratio of 1.50 times, RM1.11 billion in bank borrowings (RM640.75 million due within 12 months from its financial year ending 31 December 2023 (FY2023)), and a negative operating cash flow of RM145.90 million for FY2023. Additionally, CHGB had established a Perpetual Medium-Term Note (MTN) Programme of up to RM500 million on 6 December 2023 and issued its first tranche of RM30 million on 22 December 2023 with a fixed rate of 7.50% p.a. Directors of CHGB had also advanced RM89.34 million to the company as of 31 December 2023.

Against this backdrop, securing an additional RM250 million loan from a bank seems improbable, especially without collateral. Considering CHGB's high leverage and liquidity concerns, banks would likely shy away from the loan application. Even if a risktaking lender were willing to lend to CHGB, a significant spread over the existing average cost of borrowing would be justified due to:

- i. **Higher risk:** The absence of collateral increases the lender's risk.
- ii. **Market conditions:** Prevailing economic conditions and interest rate environment.
- iii. **Company-specific factors:** CHGB's financial leverage, negative cash flow, and existing debt obligations.

## **POTENTIAL CONFLICT OF INTEREST**

CHGB's substantial 55.85% stake in Ajiya sets the stage for a strategic partnership but also introduces conflicts of interest. Decisions favouring CHGB may not align with Ajiya's shareholders' best interests.

Lending substantial funds to a closely affiliated, highly leveraged company to expand similar businesses might be construed as prioritising CHGB's growth over Ajiya's interests. Specifically, RM50 million of the loan will be used by CHGB to expand its building material division, which could have been redirected towards Ajiya's own expansion initiatives.

Ajiya claimed the loan represents a strategic shift, allowing the group to re-mobilise its excess capital and provide necessary funding to CHGB. However, this rationale appears contradictory given Ajiya's recent sale of freehold land in Thailand for 208 million Baht (approximately RM26.79 million) to improve liquidity and strengthen its financial position. If Ajiya has excess capital, why did it sell the freehold land to enhance liquidity and fortify its financial position?

It was also disclosed that Ajiya generated RM3.31 million in interest and dividend income, representing an average return of 2.13% per annum on its average other investments balance of RM155.20 million in FY2023. This is puzzling, especially considering its investment portfolio grew from RM114.15 million in FY2021 to RM184.01 million in FY2023. If returns are as modest as claimed, Ajiya should have returned the excess capital to its shareholders, including the minority shareholders, rather than funding the major shareholder CHGB. Conversely, CHGB could have explored other funding options, such as issuing new tranches of Perpetual MTN or securing advances from directors to fund its expansion plans. Such approaches would be more straightforward than turning to Ajiya for financial assistance.

## **DOMINO EFFECTS**

The loan extended to CHGB is earmarked for acquiring stakes in Chin Hin Construction Engineering Sdn Bhd (CHCE) and Kayangan

Kemas Sdn Bhd (KKSB) from Chin Hin Group Property Berhad (CHGPB), a 50.99%-owned subsidiary of CHGB. Notably, CHGPB exhibits a high gearing level and consistently records negative cash flows from operations. CHGB also intends to deploy up to RM50 million of the loan for expansion via joint ventures, collaborative arrangements, business agreements, and/or mergers and acquisitions of similar businesses. These include raising its equity stake in Signature International Berhad (SIB) and CHGPB.

The primary risk of such an arrangement lies in CHGB's ability to meet its financial obligations. Should CHGB's expansion plans falter, the loan repayment obligation could strain itself, consequently impacting Ajiya's financial position. Worse yet, Ajiya might be under significant financial pressure should CHGB fail to fulfil its commitments, potentially resulting in losses and damages under the loan agreement. Given CHGB's substantial stakes in related companies, fluctuations in the performance of one entity could reverberate across others, amplifying volatility. This intricate web of interconnectedness elevates risk exposure and complicates CHGB and Ajiya's financial stability.

## SYNERGY OR RISKS? A DOUBLE-EDGED SWORD

Ajiya anticipates that the strategic alliance will drive demand for its offerings of metal, safety glass, and Ajiya Green Integrated Building System (AGiBS). Further, the loan is expected to bolster CHGB's capacity to undertake additional construction and property development projects, potentially expanding Ajiya's revenue base. However, CHGB's current revenue contribution to Ajiya is minimal. Sales to CHGB totalled approximately RM3.08 million from 1 December 2023 to 30 April 2024, compared to Ajiya's Q1FY2024 revenue of RM78.93 million.

While the strategic alliance and synergy with CHGB seem beneficial, they pose significant risks. This is a double-edged

sword: as Ajiya supplies more building materials to CHGB, it is increasingly exposed to the credit risks associated with CHGB. Any setbacks in CHGB's projects could result in delayed payments for Ajiya's supplied materials, jeopardising loan and interest repayments. In short, while the synergy with CHGB could unlock new opportunities, the associated risks and financial implications warrant scrutiny and careful consideration. This alliance could either propel Ajiya forward or set off a chain of domino effects if CHGB's expansion plans do not materialise as planned.

## A BOLD STEP FORWARD WITH CAUTION

Ajiya's financial support for CHGB ostensibly aims to fortify its financial position and ensure sustainable growth. However, this endeavour is fraught with considerable risks and potential conflicts of interest. Minority shareholders of Ajiya find themselves bearing significant risks. The decision to extend a loan to CHGB at a 7.5% interest rate p.a. may underrate the risks associated with CHGB's operations.

Meanwhile, Ajiya's justification for divesting other investments due to meagre returns while simultaneously funding CHGB raises valid concerns about protecting minority shareholders' interests, effectiveness of resource allocation and capital distribution.

One must tread carefully in this intricate financial landscape, for the shadows of risk and conflict loom large over one's path.


