ccording to Minister in the Prime Minister's Department Datuk Seri Mustapa Mohamed, the retail sector is expected to recover in the second half of 2020 boosted by local consumption, with sales likely to recover to 80 per cent of pre-Covid-19 levels in the fourth guarter from the 70 per cent currently. There have been signs of a recovery as the economy re-opened based on the improved unemployment figures released by the Statistics Department which stated that Malaysia's June 2020 unemployment rate declined monthon-month to 4.9 per cent from a record high of 5.3 per cent in May 2020 as more sectors, including the services industry, reopened to revive the country's economy while curbing the Covid-19 pandemic. He foresees the country seeing further economic recovery in the third and fourth quarters, on par with Bank Negara's 2020 gross domestic product growth forecast of -3.5 per cent to -5.5 per cent after a contraction of 17.1 per cent in the second quarter this year.

Vehicle sales expand 13% year-on-year in July despite Covid-19 pandemic

According to Malaysia Automotive Association (MAA), the monthly vehicle sales volume in July grew 13% to 57,552 from 50,854 a year earlier. Passenger vehicle sales increased 13%, while commercial vehicle sales grew 16% to 5,433 from 4,665. On month-on-month comparison, the country's vehicle sales soared 29% over June's figure of 44,695 units. It was attributed to the impressive sales figures for the month to the sales tax exemption incentives for vehicles, aggressive marketing campaigns conducted by car companies as well as a longer working month. The Malaysian automotive industry is expecting sales in August to be maintained at July's levels, buoyed by the ongoing sales tax exemption and attractive promotional campaigns by car companies

Opportunities still aplenty in Malaysia's retail sector

According to Fitch Solutions, the research arm of Fitch Ratings, the Covid-19 pandemic may have changed consumer habits in Malaysia, but there are still opportunities within the retail space which can be tapped into, even though consumers' spending habits remain focused on the home. Overall, total retail sales in Malaysia contracted by -9.2% year on year in June 2020, but is still a marked improvement on the decline recorded in April 2020 of -32.4% year on year, indicating a recovery moving in sync with the reopening of the country's economy. Google Mobility data for July 2020 shows that mobility to public transit stations remains at -24% lower than the baseline period recorded in January and February. Similarly, mobility to workplaces is down -18.2% to the baseline. It highlighted in a report that three consumer trends have emerged in the recovery movement control order period (RMCO) which consumer-facing retailers in Malaysia can take advantage of. These are: (1) consumers focusing on speciality stores for their priority goods, (2) work from home, invest in the home and (3) the rapid development of e-commerce. Referring to the Department of Statistics figures, retail sales at non-speciality stores continued to contract, declining by 1.2% on-year in June 2020, while speciality stores selling food, beverages and tobacco products continue to post positive growth, with sales growing by 3.4% on-year for June. This is Malaysian consumers prioritising their basic essentials, making the conscious choice to avoid crowded supermarkets (where goods may be relatively cheaper) and choosing speciality grocery stores to do their shopping. This trend will continue over the short term, as Malaysian consumers choose to limit their exposure to crowded areas. It added that globally, there is a trend of consumers staying at home and investing in their home and it believes that this trend is starting to play out in Malaysia, hence the recovery trajectory for household goods. This bolsters their view that the Covid-19 pandemic will function as an accelerator for e-commerce adoption globally.

Almost half of manufacturers plan 30% job cuts by year-end

According to Federation of Malaysian Manufacturers-MIER Business Conditions Survey for 1H 2020, about 42% of respondents from the manufacturing sector are planning to cut costs by reducing their headcount by as much as 30% come

the end of this year, in a bid to keep their businesses afloat during the pandemic-induced slump. The survey also revealed that retrenchments by manufacturers will be likely in 2021, with 42% of the respondents saying they will continue to cut staff count, albeit by a smaller quantum of 10% to 20%. FMM president Tan Sri Soh Thian Lai said that due to new normalcy and SOP to comply with, the manufacturing output has been reduced. Hence, manufacturers do not need so much manpower. One of the ways to reduce cost is cut down manpower

Oil holds weekly gain as gloomy economic signals damp rebound

According to a Bloomberg report, oil clung onto its third week of gains, despite a retreat since mid-week on gloomy economic signals in the U.S. and a cautious tone from the Federal Reserve and OPEC+ producers. Futures in New York were little changed, after falling 0.7% on Thursday. Applications for U.S. unemployment benefits unexpectedly increased last week, boding poorly for fuel consumption as millions of Americans remain out of work. That followed downbeat comments from the Fed and OPEC+ the previous day on the prospects for an economic recovery as authorities around the world struggle to contain the pandemic. Crude for October is up more than 1% this week, helped by an ongoing decline in U.S. stockpiles. The message from this week's meeting of OPEC and its allies was that the market remains fragile and the demand outlook uncertain, with fresh pressure exerted on quota cheats to deliver on promised output curbs

RAM Rating: Malaysian bonds benefit from sustained foreign demand in July

According to RAM, Malaysian bonds have been popular, charting their third consecutive net foreign inflow in July (+RM7.1 billion). The consistent inflow had largely offset panic selling during the height of the pandemic, with the year-to-date net inflow currently standing at RM1.3 billion. Consequently, foreign holdings of the Malaysian Government Securities/ Government (MGS) Investment Issue rose to 23.5 per cent of the total outstanding in July, close to the 23.9 per cent in February — pre-Covid-19. In contrast, the participation rate in Thailand and Indonesia stayed on a downtrend despite seeing a consistent return of foreign demand. In line with robust foreign demand, yields trended down through July. This broad-based decline was also driven by the Bank Negara Malaysia's fourth overnight rate policy (OPR) cut this year, for a total of 125 basis points (bps) year to date to 1.75 per cent — the lowest since the introduction of this policy tool in 2004. Concurrently, the benchmark 10-year MGS yield fell to a record low of 2.62 per cent as at end-July (-32.2 bps m-o-m) while the shorter-term one-year MGS hit a fresh low of 1.78 per cent (-26.9 bps m-o-m). Looking ahead, it expects domestic bond yields to stay suppressed amid the abundance of global liquidity and not discounting another round of OPR cuts by the central bank and that the OPR could possibly end 2020 at 1.50 per cent.

This week, on Wednesday (19Aug), the Ringgit gained to 4.1825 against the USD from 4.1875 on Monday (17Aug), recovering from last Friday's low. Meanwhile, the Ringgit was 3.0631 to the Sing Dollar on Thursday (19Aug).

On Monday (17Aug), the FBM KLCI shed 3.85 points or 0.25% lower to 1560.74 from previous Friday's close

of 1564.59. And as at Friday (21Aug) 10:00am, the FBM KLCI has been on a sideways mode to 1572.47 weighed down by continued volatility on the glove stocks and other Index-linked stocks








