

# an investment opportunity or a value trap?

# **SUMMARY**

- Ta Ann Holdings Bhd (Ta Ann or the Group) (TAANN 5012.MY) has shown consistent top-line and bottom-line growth over the past decade, with diversified operations in timber and plantations.
- It has created shareholder value by achieving returns above its cost of funds. The company also has a robust balance sheet, with low debt, strong liquidity, and consistent positive cash flows.



 Ta Ann's market price about 6 months ago was below its intrinsic value, with a margin of safety based on both asset and earnings valuations. As such it was not a value trap.

# THRUST OF MY ANALYSIS

Investing requires more than just looking at a company's profitability or market trends. A structured framework that evaluates stocks across two critical dimensions - business fundamentals and investment risk - provides a comprehensive view:

- Business Fundamentals measure a company's operational and financial strength, such as growth, profitability, and returns.
- Investment Risk assesses how the current market price compares to its intrinsic value, providing insight into the stock's margin of safety.

I hope that this two-dimensional perspective, as exemplified in this article, will help investors discern whether a stock is an undervalued opportunity or a potential value trap.

# **BACKGROUND**

Ta Ann has 2 main business segments – Timber and Plantations.

The Timber segment has 4 main operations – logging, plywood, saw-milling, and re-forestation.


- Plywood was the largest contributor accounting for slightly less than 2/3 of the Timber segment revenue in 2023.
- The Group has 2 plywood operations one in Malaysia and another in Tasmania, Australia.



- The sawmilling operation is comparatively small.
- Ta Ann is one of the pioneers in forest plantation in Sarawak with 31,000 hectares of planted trees in 2023.

The Group entered the palm oil sector in 2000 and today has 13 oil palm estates covering a total land area of 72,499 hectares. It operates 3 palm oil mills near its estates.

Over the past 12 years, the Plantation segment has overtaken the Timber segment in terms of revenue and EBIT contribution. Refer to Chart 1.



# **OPERATING PERFORMANCE**

Over the past 12 years, there were uptrends in revenue, PAT, and gross profitability. But as shown in the left part of Chart 1, PAT was more volatile with a spike in 2021 due to about 50% growth in revenue and gross profit margin. If you refer to Chart 1, you can see that this was due to the Plantation segment. According to Ta Ann:


"Fresh fruit bunches... production in 2021 was almost at par with 2020, but our pre-tax profit for oil palm segment had more than doubled...average selling price of CPO and FFB surge by 63% and 71% respectively."

Palm oil and plywood prices are cyclical and with the price decline in 2023, PAT declined. You can see this cyclical pattern clearly in the profit pattern in the left part of Chart 2.

We see similar patterns for the returns. Refer to the right part of Chart 2. Over the past 12 years,

- ROIC ranged from 3% to 19% with an average of 9%.
- ROE ranged from 5% to 22% with an average of 11%

The average returns were greater than the current cost of funds indicating that despite the volatile returns, Ta Ann created shareholders' value.



# PEER COMPARISON

Ta Ann has 2 main operations – timber and oil palm. As such I compared its performance with companies in the timber and oil palm sector. There are about 40 Bursa plantation companies many of which are much larger than Ta Ann in terms of revenue. As such I selected 3 plantation companies with about the same 2023 revenue as that for Ta Ann - BLD Plantation, Kim Loong, and United Plantation.

For more details on the Bursa plantation sector, refer to my blog article "How the Malaysian plantation sector performed over the past 10 years"

As for the timber companies, I chose 3 that have both timber and oil palm operations – Jaya Tiasa, Subur Tiasa, and WTK. Table 1 summarises the 2023 revenue and revenue growth from 2012 to 2023.

- Ta Ann delivered the best revenue growth when compared to the timber companies.
- I would consider Ta Ann's revenue growth as ok when compared to the oil palm plantation companies.
- Ta Ann was also among the top performers when I looked at the return on capital and Debtequity ratio.

I would conclude that Ta Ann stood out within the industry.

# FINANCIAL POSITION

I would rate Ta Ann as financially strong.

- As of Sep 2024, it had RM62 million cash and cash equivalents. This is about 17% of the total assets.
- As of Sep 2024, it had a Debt Equity ratio of 7%. This had come down from its 2013 high of 50%.
- From 2012 to 2023, it generated positive cash flow from operations every year. During this period, it generated a total of RM3.1 billion in cash flow from operations compared to a total net profit of RM1.9 billion. This is a good cash conversion ratio.

- Over the past 12 years, its average Reinvestment rate (Reinvestment/NOPAT) was 17%. I defined Reinvestment = CAPEX & acquisition - Depreciation & amortization + increase in Net Working Capital. This low rate meant that a large part of the profits could be returned to shareholders.
- It has a good capital allocation plan as shown in Table 2. Its cash flow from operations was sufficient to cover its CAPEX and the balance was used to reduce debt and pay dividends. I had earlier

mentioned that the Group created shareholders value. This meant that investments in CAPEX and acquisitions were value-accretive.

# **VALUATION**

The Asset Value of Ta Ann is RM4.34 per share (as of Dec 2024) compared to its market price of RM3.87 per share (as of Sep 2024). I estimated its Earnings Value to be RM7.85 per share. You can see that there is more than a 30% margin of safety under the Earnings Value. Refer to the original article for details of the valuation. When evaluated against its Earnings Value, the stock appears significantly undervalued, reflecting low investment risk.

# **CONCLUSION**

When evaluating stocks, two critical dimensions come into play: business fundamentals and investment risk. Business fundamentals assess the operational and financial strength of a company. Investment risk considers how the current market price compares to its intrinsic value.

Understanding where a stock lies across these dimensions can help determine whether it is a value trap or an attractive opportunity. I would consider Ta Ann sound from a fundamental perspective:

- There were topline and bottom-line growths.
- It had diversified into the plantation sector which delivered a big part of the growth.
- It is financially sound.
- It has been able to create shareholders' value.

At the same time, there is more than a 30% margin of safety under the Earnings Value.

Ta Ann is more than a timber and plantation company. It is a testament to disciplined financial management, adaptability, and shareholders' value creation. While cyclical commodity prices may impact short-term results, the company's fundamentals and valuation suggest significant upside potential. You can see why I do not consider Ta Ann a value trap.

I am a long-term value investor who has held onto stocks for more than 5 years. My analysis and valuation are from such a perspective. I consider quarterly results "noisy" and focus on long-term trends.

# MALAYSIA **ONTRACKTO MEET 2025** GDP GROWTH TARGET DESPITE **US-CHINA** TRADE WAR - RAFIZI

ccording to Economy Minister Datuk Seri Rafizi Ramli, Malaysia is on track to meet its 2025 GDP growth target despite the US-China trade war. This is on the back of drivers that include chip demand supporting medium to long-term prospects. And the key hypotheses that have driven interest in the Malaysian economy over the past year remain unchanged.

He observed the projection that the world is going to be more digital, and AI is going to be mainstream has not changed. The demand for chips will go up, which will bolster Malaysia's trade. Malaysia's long-term plan to ensure that it plays a pivotal role in the global supply chain has not changed either. He was speaking to reporters after the launch of "A Fresh Take on Reducing Inequality and Enhancing Mobility in Malaysia", a joint report by the World Bank and the Ministry of Economy. The joint report highlights the importance of building on progress to ensure that everyone benefits. Strengthening access to quality education, healthcare and employment opportunities will be key to ensuring that economic prosperity is shared by all. To address inequality, the government will adopt a holistic assessment, early intervention on opportunity gaps, and commit to creating a dynamic labour market.

Rafizi added that the stronger Ringgit over the last week indicates that investors and market participants have a positive outlook on Malaysia's economy. The strengthening of the Ringgit is very much the function of the market because of the evolving and developing nature of the trade war that is happening now. He noted that market expectations, speculation and projections will inevitably impact the Ringgit's movement.

He said that we have to navigate through the changes and volatility with the hope it is not going to be extreme. He also added that the government is monitoring the situation closely, with MITI tasked with evaluating the trade war's potential impact.

He noted that the government will take guidance from MITI on the official stance. As of now, there is no discussion on revising Malaysia's economic growth outlook. Typically, the government's growth forecast is finalised and shared closer to the budget unless there are drastic developments.

# **5G** SUBSCRIPTIONS NATIONWIDE REACH 18.19 MIL IN 4Q 2024— FAHMI


ccording to Communications Minister Fahmi Fadzil in a Facebook post, the number of 5G network users across the country has reached 53.35%, or 18.19 million subscriptions, as of the fourth quarter of last year. This achievement was the best in a short period and marked a significant step towards developing better telecommunications infrastructure for all.

He stated that this positive development was among the items presented at the 5G Dual Network Implementation Coordination Meeting which he chaired at the Ministry of Communications. He added that 5G coverage in populated areas nationwide had reached 82.4% during the same period, further strengthening the country's digital infrastructure.

And that this will open up more opportunities for innovation, increase productivity and bring benefits to the people of Malaysia. The meeting also discussed and decided on several specific matters concerning the direction of Digital Nasional Berhad (DNB) and the second network led by U Mobile, which will be announced soon.

Over in US, the overnight Dow Jones Industrial Average closed down 125.58 points (-0.28%) to 44,747.70 whilst the NASDAQ added 99.66 points (+0.51%) to 19,791.99.

he convictions of two major shareholders over personal data breach offence across the Strait of Johor may have caught Rexit's shareholders off guard. That said, it is commendable that Rexit has taken proactive measures to ensure its data integrity, mitigate the damage, and work toward restoring investors' confidence.

# **EXIT OF ETHICS – REXIT'S DATA CONCERN**

Takeover bid, massive board revamps, criminal convictions, and data breach allegations, sound pretty much like plots in business movies or TV series, except they are real-life events.

Following a takeover bid led by Dato' Seow Gim Shen (Dato' Seow) and a group of companies in February 2024, the past year has been a roller coaster ride for Rexit Berhad, a Software as a

Service (SaaS) solutions provider listed on the Main Market Bursa Malaysia.

In February 2024, Dato' Seow, Metaco Asset Holdings Sdn Bhd (Metaco) and Bemas Holdings Sdn Bhd (Bemas) made their grand entry into Rexit via the acquisition of 53.27% of the listed entity for RM78.4 million, or 85 sen apiece from Rexit Venture Sdn Bhd, Global Hartabumi Sdn Bhd and Datuk Chung Hon Cheong (Datuk Chung) via direct business transaction. The takeover resulted in a mandatory general offer to acquire all the remaining shares at a cash consideration of 85 sen per share.

A boardroom revamp ensued after the ownership changed hands. On 11 March 2024, Dato' Seow was appointed as Chief Executive Officer of Rexit. Another three new appointments were made on the same day, with two new independent directors and one nonindependent and non-executive chairman appointed on board. Meanwhile, a Chief Operating Officer with extensive technology and digital transformation background was roped in.

Just when everything seemed to be going well for the Company, things took a sharp turn. On 24 October 2024, news started making rounds that Rexit's two major shareholders - Dato' Seow and Kong Chien Hoi (via his interest in Metaco Assets) were each sentenced to 14 weeks' jail in a Singaporean court for participating in a conspiracy to illegally obtain data of over 9,000 people.

According to a report by The Straits Times<sup>1</sup>, both had pleaded guilty to one charge each of conspiring with Chinese national Sun Jiao to have the personal information of 9,369 unknown individuals supplied to them for gambling operations. Also, it was reported that Sun was allegedly linked to a global syndicate that conducted malicious cyber activities.

Following the fallout of its major shareholders, Rexit saw its share price slide from 76 sen on 23 October 2024 to a 52-week low of 69 sen on 28 October 2024, representing a 9.2% slide within three trading days.

The counter slid from its all-time high of RM1.44 on 26 March 2024 to 77 sen as of 20 January 2025.

As of the time of publication, Dato' Seow and Metaco's stake in Rexit remained unchanged at 23.33% and 18% respectively. According to bourse filings, Dato' Seow resigned from the Board on 11 October 2024, six weeks after he was redesignated as Executive Chairman, "to focus on personal commitments and the growth of his other new business ventures2".

# **DATA GOVERNANCE AND DATA INTEGRITY**

Data integrity is paramount for Rexit, given its mainstay of providing SaaS solutions to the financial services sector, particularly the general insurance industry. Rexit's flagship product, e-Cover, provides insurance companies and insurance agents a platform to consolidate the entry of insurance transaction data, eliminating reliance on manual input by insurance company personnel. According to Rexit's website, thousands of insurance agents, more than ten insurance companies in Malaysia, one in Singapore, five banks and telcos utilise its e-commerce portal. Additionally, Rexit develops, manages, and operates the mySalam portal, a national health protection scheme serving eligible members.

Beyond its core business in the insurance sector, Rexit has expanded its SaaS model to the unit trust industry with the e-PPA system, facilitating the submission of unit trust investment and redemption applications using EPF contributions.

On 21 October 2024, Rexit announced the decision to appoint an independent cybersecurity firm to reaffirm the security of its organisational data against potential breaches. This decision came just three days before the sentencing of Dato' Seow and Kong in a Singaporean court.

Subsequently, on 1 November 2024, Rexit engaged LE Global Services Sdn Bhd (a subsidiary of ACE Market-listed LGMS Berhad) to perform a cybersecurity audit. This was in addition to internal audit findings, which concluded that there were no data breaches and that the company's data security processes were resilient against threats.

Following the investigation by LE Global Services, Rexit announced on 6 January 2025 that findings from the cybersecurity firm reaffirmed its earlier internal findings that there were no signs of compromise nor data leaks in either the open or dark web related to the shared services applications it operated.

Given Rexit's core business revolves around financial institutions, personal data, and financial transactions, it cannot afford to take cyber threats lightly. However, compared to PLCs with material cybersecurity risks, Rexit has disclosed relatively little about its measures to safeguard data privacy and security3. Its two-page sustainability statement made no mention of materiality matters with significant impacts on its business activities, including cybersecurity, data privacy, or data governance.

At this juncture, the financial impact of this incident on Rexit remains uncertain pending the release of its quarterly results ended 31 December 2024 tentatively in February 2025. Nevertheless, in an interview with local media in October 2024, Rexit's adviser Datuk Chung acknowledged that the episode

involving Dato' Seow would impact the confidence of customers, resulting in short-term impacts on its new business to the tune of "10% to 15%" 4.

Shareholders should also take note that the Company changed its fiscal year-end to 31 December 2024, from 30 June 2024 earlier. Following this, Rexit has been granted by the Companies Commission of Malaysia for the extension of time up to 30 September 2025 to hold its 20th AGM in accordance with Section 340 of the Companies Act 2016.

For the 15-month reporting period ended 30 September 2024, Rexit raked in RM15 million of net profit against RM39.61 million in revenue. For FY2023, it recorded revenue and net profit of RM27.29 million and RM11.01 million, respectively.

# CONCLUSION

Trust takes years to build, seconds to shatter, and a lifetime to restore. While Rexit has cleared the suspicion of data breach, the reputational damage inflicted by this saga may take years to mend. The chronicle of events in Rexit underscores the critical importance of ethics and governance in a company. Directors or shareholders with a history of criminal misconduct may severely damage a company's reputation, eroding stakeholder trust and hindering its ability to attract investments or forge partnerships.

That said, it is commendable that Rexit has taken proactive measures, including both internal and external audits, to ensure the integrity of its database, mitigate the damage, and work toward restoring investors' confidence.

Will Rexit be able to return to its all-time highest share price of RM1.44? Only time will tell.
