Govt introduces **Kita Prihatin**, a targeted wage subsidy programme

Prime Minister Tan Sri Muhyiddin Yassin announced that the government is introducing a Targeted Wage Subsidy Programme to assist employers and employees in certain sectors which are still affected economically by Covid-19. To be open for applications from Oct 1 to Dec 31 2020, the programme was expected to benefit 1.3 million workers and estimated to involve RM2.4 billion. This is under the Prihatin Supplementary Initiative Package (Kita Prihatin). This initiative follows the Wage Subsidy Programme launched earlier under the Prihatin Rakyat Economic Stimulus Package, which is set to end on Sept 30. For the Targeted Wage Subsidy Programme, wage subsidies will be given to employers that are still affected, namely companies that since the Recovery Movement Control Order (RMCO) still face lower revenues of at least 30% compared to last year. The wage subsidy will be given for up to three months at a rate of RM600 per month for each employee, with a maximum of 200 employees per company. Based on feedback on the Wage Subsidy Programme, there were those who were not eligible to receive it as they did not meet the eligibility requirements of being registered with the Social Security Organisation (SOCO) prior to April 1, 2020. To ensure this group is not left behind, the Targeted Wage Subsidy Programme will be open for companies registered with SOCO prior to Sept 1, 2020. For new applicants who have not received the wage subsidy prior to this, they will now be eligible to receive the wage subsidy for up to six months. The Kita Prihatin package targets four main groups, namely the bottom 40% income group (B40) who are married and single; M40 group with family and who are single; local workers in various fields and micro-traders in various fields.

Bank Negara's international reserves rise to US\$104.8b

According to Bank Negara Malaysia (BNM), its international reserves amounted to US\$104.8 billion as at Sept 15 2020, up 0.38% from the US\$104.4 billion that was recorded on Aug 28. The reserves position is sufficient to finance 8.7 months of retained imports and is 1.1 times the total short-term external debt. Of the components of the international reserves, foreign currency reserves slipped to US\$96.3 billion from US\$97.3 billion previously, while International Monetary Fund reserves, Special Drawing Rights and gold were unchanged at US\$1.3 billion, US\$1.1 billion and US\$2.2 billion respectively. Other reserve assets, meanwhile, rose to US\$3.9 billion from US\$2.5 billion. The bank's total assets stood at RM502.21 billion as at Sept 15 versus RM499.84 billion as at Aug 28.

Malaysia recorded approved investments totalling RM64.8b in 1H20

According to Malaysian Investment Development Authority (MIDA), Malaysia recorded a total of RM64.8 billion worth of investments in the manufacturing, services and primary sectors in the first six months of 2020 (6M20) despite multiple headwinds on the global front. The investments involved 1,725 projects and would create 37,110 employment opportunities in Malaysia. Of the total investments approved, domestic direct investment (DDI) accounted for 69.8%, or RM45.3 billion, while foreign direct investment (FDI) made up the remaining RM19.5 billion. The top five sources of FDI for the manufacturing, services and primary sectors during the period were Singapore (RM4.9 billion), Switzerland (RM2.8 billion), China (RM2.2 billion), the US (RM2.2 billion) and Thailand (RM1.8 billion). For approved projects by state, the five major states — namely Sabah, Selangor, Pulau Pinang, Kuala Lumpur and Johor — contributed RM47.1 billion (72.6%) to total approved investments for the period.

The manufacturing sector attracted the largest portion of approved investments contributing more than half (55.1%) or RM35.7 billion, followed by the services sector with 44.2% of investments or RM28.6 billion, and the primary sector with 0.7% of approved investments or RM500 million. Investments approved for the manufacturing sector were mainly in petroleum products, including petrochemicals (RM13.6 billion), machinery and equipment (M&E) (RM5.2 billion), electrical and electronics (E&E) products (RM5 billion), food manufacturing (RM2.1 billion), scientific and measuring equipment (RM2 billion), transport equipment

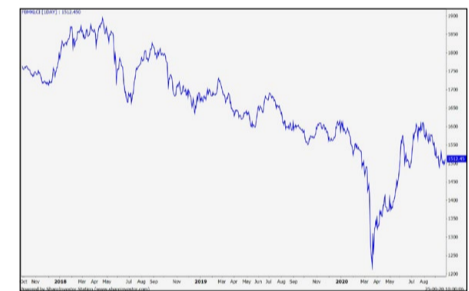

(RM1.8 billion), chemicals and chemical products (RM1.6 billion), and non-metallic minerals (RM1 billion). These made up 90.2% of total approved investments in this sector. With a total of 398 projects, these newly approved investments are expected to create 26,940 jobs for the country. The jobs being created include managerial roles (1,925), technical and supervisory roles (4,887), craft skill professionals (3,226), machinery operators and installers (11,117), as well as sales and clerical personnel (1,881). The states that recorded the highest total approved investments in the manufacturing sector during the period were Sabah, Pulau Pinang, Johor, Selangor and Terengganu. These states collectively contributed RM29.7 billion.

Most banks can shoulder coronavirus shock but new lockdowns are key risk

According to Moody's Investors Service the global banking system is well placed to absorb the economic shocks triggered by the coronavirus but a second wave of the virus, leading to new blanket lockdowns or self-imposed changes in consumers' behaviour, poses a significant threat. The outlook for global banks turned overwhelmingly negative in early 2020 as the pandemic struck and restrictions on economic activity began to bite. Over three-quarters of 70 Moody's Banking System Outlooks are now negative, which contrasts with the 14 per cent that was negative at the end of 2019. However, after 10 years of broadly benign economic conditions, and relentless regulatory pressure to reinforce balance sheets, most banking systems are in good shape and can withstand the inevitable rise in bad debts over the coming months. In addition, actions taken by central banks and governments to soften the virus impact have slowed the rise in asset risk and underpinned liquidity and funding. In a context of profound uncertainties, the ability to preserve and restore capital in the medium term will be a crucial support to banks' creditworthiness. European banks are at an advantage because their starting capitalisation is higher than banks in most other regions. Banks with more diversified business models — notably those with capital market activities — will also prove more robust than those focused on more susceptible activities like lending to small businesses and corporates. Challenges will be greatest in areas where profitability was already weak such as Japan and Europe, and where necessary restructuring is consuming pre-provision profits and reducing loss absorption. Similarly, rapid digitalisation and low-interest rates will further compound the risks facing banks with lower efficiency.

This week, on Thursday (24Sep), the Ringgit slipped to 4.1635 against the USD from 4.1105 on Monday (21Sep). Meanwhile, the Ringgit was 3.0289 to the Sing Dollar on Thursday (24Sep). On Monday (21Sep), the FBM KLCI lost 7.20 points or 0.48% to 1499.43 from previous Friday's close of 1506.63. As at Friday (25Sep) 10:00am, the FBM KLCI gained 11.7 points to 1512.45 but still within the 1540 - 1474 range since the start of the month. Meanwhile US stocks were just slightly higher after close on Thursday, led by marginal gains in the Utilities, Basic Materials, Telecoms and Tech sectors. The Dow was at 26,815.44 (+52.31) and the NASDAQ was at 10,672.27 (+39.28).
