Bursa Malaysia Derivatives named 'Exchange of the Year — Asia Pacific'

ursa Malaysia Derivatives (BMD) has been named the 'Exchange of the Year — Asia Pacific' by the London-based Global Investor Group at the Futures & Options World (FOW) International Awards 2020. According to BMD chairman Datuk Muhammad Umar Swift, who is also chief executive officer of Bursa Malaysia Bhd, the FOW International Award is a significant honour to end the year with. It validates Bursa's commitment to serve its clients' needs in providing a reliable hedging instrument against price volatilities, which have been critical, given the Covid-19 pandemic this year. It has been a record year and on behalf of BMD, he conveyed his appreciation to the industry for the trust and confidence in Bursa Malaysia's derivative product offerings in managing price and risk exposures. As of November, BMD saw 13.5 million contracts or 337.5 million tonnes traded, representing seven times Malaysia's total palm oil production, and 4.5 times the global palm oil production. BMD recorded over 20 trading record highs across all its products over the past 12 months, with the latest historical record achieved on Oct 28, with total trading volume for crude palm oil futures contract touching a new high of 12 million lots, breaking the previous record of 11.91 million lots achieved in 2017.

Govt launches MalaysiaBiz portal to boost SMEs

According to the prime minister of Malaysia Tan Sri Muhyiddin Yassin, the digital economy, designated as one of the main pillars of the Shared Prosperity 2030 vision, will be given special attention to spearhead the country's post-Covid-19 revival. One of the areas that will be given emphasis is the development of small and medium enterprises (SMEs), especially those trying their hand at e-commerce. In facing the economic impact of the Covid-19 pandemic, the government has taken an inclusive approach in ensuring the economic survival of the people. This digitisation process will be intensified and focus will be given to the development of the digital economy to boost the country's economic growth after Covid-19. SMEs contributed 38.9% to gross domestic product (GDP) in 2019 and the government wants the percentage to reach 50% by 2030. Measures to boost the growth of SMEs will continue to be given priority. This is especially looking at today's online buying trends, which is a potential for SMEs to grow rapidly. The intention is to simplify the digitisation process among traders. The government is targeting a 40% digitisation of end-to-end (E2E) service delivery by the end of 2020, compared to 20.2% in 2019. The commitment to boost SMEs was reflected in many initiatives, including those introduced in previous economic stimulus packages. The recently tabled Budget 2021 also placed business continuity as one of three main goals. Special attention has been given to SMEs $through \, fund \, assistance, training, \, digital \, equipment \, and \, grants. \, The \, government \, has \, also \, digital \, equipment \, and \, grants \, digital \, equipment \, and \, grants \, digital \, equipment \, equipment \,$ allocated RM1bil to boost digitalisation activities until Dec 31, 2023. A sum of RM150mil has been set aside to organise sales training programmes and to procure digital equipment for 100,000 local entrepreneurs under the e-Commerce SME and Micro SME campaigns. Additionally, a total of RM4.6bil has been allocated to empower bumiputra and women entrepreneurs. Conducted virtually, the launch of the Malaysia Biz portal was a superior of the B broadcast on Malaysian Administrative Modernisation and Management Planning Unit's Facebook page. The portal will serve as a "one-stop centre" that eases the registration of online businesses as well as licensing applications. The aim of the MalaysiaBiz portal is to create a trade-friendly environment, which would in turn encourage competitiveness and also spur the growth of the domestic economy. He called on more Malaysians to take advantage of the MalaysiaBiz initiative by starting new businesses.

BNM assistant governor warns of 'unethical advice' to punt EPF Account 1 withdrawals on riskier investments

Bank Negara Malaysia (BNM) assistant governor Fraziali Ismail has warned against "unethical advice" encouraging members of the Employees Provident Fund (EPF) who are not in financial distress to withdraw from their Account 1 to invest in investment assets that carry much higher risks, after the enhanced i-Sinar facility was announced by the fund. He said this after self-proclaimed financial gurus on social media irresponsibly advised borrowers who are not facing financial difficulties to seek loan moratoriums or channel their savings from the deferred loan repayments into higher risk investments to make quick returns. What they fail to mention is that while it helps in easing cash flow problems for those affected, moratoriums do come at the cost of higher overall borrowing costs to the consumers, who may even be faced with the prospect of loan defaults should these short-term investments go sour. In such circumstances, all financial practitioners are expected to serve as a source of sound financial advice to counter such unscrupulous publications and to dissuade clients from making irrational financial decisions that are not in their best interest. This may require financial practitioners to take the higher ground, to set aside the temptation to promote such risky investments or insurance products that can earn high commissions. While this may dampen earnings prospects in the short term, they stand to gain the trust, confidence and loyalty of clients over the long term. I have faith that all financial practitioners will rise to this challenge and contribute to the building of a financial intermediation industry that is both profitable and ethical. Under the i-Sinar facility, contributors with not more than RM100,000 in their Account 1 can withdraw up to RM10,000 over a period of up to six months. Meanwhile, those who have more than



RHB revises downwards Malaysia's 2021 GDP growth forecast to 6.3%

According to RHB's group chief economist and head of market research Dr Sailesh Kumar Jha, Malaysia's growth for 2021 has revised downwards to 6.3% from a previous projection of 7%. Despite the downward revision, the projected growth as still fairly robust. The consumer sentiment is slowing and likely to slow moving into the first half of next year. It is an improvement and not on a big deceleration path. Another factor that would affect Malaysia's growth for the coming year is its position as a small open economy, where exports matter to a significant extent. To date, the pace of export growth has been fairly robust on the global level as evident in South Korea, Taiwan, China, Singapore and many other markets. A lot of it has to do with electronics and pharmaceutical sectors but as those tailwinds from global demands start decelerating, our exports projection will be lower than what the consensus is estimating. The consumer sentiment will slow, as we just started opening up in terms of movement control order (MCO) measures, so there will be a lag effect on how much economic activity picks up that feedback into labour market conditions. The high unemployment rate will create some negative sentiment on consumer spending. In 2020, Malaysia's unemployment rate hit a high of 5.3% and fell to 4.6% in the subsequent months. On the global front, the financial market is in a euphoric state, as it anticipates a V-shaped pickup in asset price to continue in the foreseeable future and that the rebound in global growth and economic activity in Asia seen since the summer of this year will continue into the next. With that, RHB takes a contrarian view based on economic policy and financial market data. The key message is that market expectations will be disappointed as we head in 2021, as there will be a downside surprise in growth globally in most countries. In addition, a further loosening of monetary policy is expected. Domestically, Malaysia's key interest rate would be held steady at 1.75%, but with a risk tilted towards a cut by Bank Negara Malaysia as early as middle of next year, should his global, macro and markets assumptions prove to be accurate. Effectively, this would emphasise Malaysia's feature as a safe-haven market. Thus far MSCI China has gone up by over 30% and US high yield bond is up by approximately 15%. However, the Malaysian equity market is only up by 0.9% and the ringgit has hardly moved against the US dollar, while the renminbi has appreciated by 6% this year. Malaysia has yet to realise this euphoric state of the global financial markets and should this euphoria subside as anticipated in first-half 2021, there would not be much correction seen domestically. By tautology, we are not going to feel that turnaround in sentiment. Simply because, we really have not benefited from it in 2020 and hence this leads to our investment idea that Malaysia's capital market will be perceived as a safe haven destination in Asia. With regard to Fitch Rating's downgrade on the country's rating to BBB+ from A-, he disagrees with some of the firm's assessments, including on the country's external liquidity conditions, as Malaysia has a large foreign investor component in the domestic bond market. The domestic and external liquidity conditions in the Malaysian capital market are fairly resilient, and that the government will come to the table in terms of fiscal consolidation once these headaches behind Covid-19 die down within the next year or so. The other rating agencies S&P and Moody's are not likely to follow suit. A factor that will affect Malaysia's growth for the coming year is its position as a small open economy, where exports matter to a significant extent.
